ADDITIONALLY, THE PLAYHOUSE OBTAINED THE SHUTTERED VENUE OPERATORS GRANT ("SVOG") FROM THE SBA IN THE AMOUNT OF \$291,359. THE PLAYHOUSE RECEIVED THE FUNDS IN OCTOBER OF 2021 AND HAS RECOGNIZED THE GRANT REVENUE IN THE FISCAL 2022 STATEMENT OF ACTIVITIES. THE SVOG FUNDS MAY BE USED FOR SPECIFIC EXPENSES AS OUTLINED IN THE AGREEMENT.
